Reservations and Payment: Creative Destinations Group requires a **deposit of 20% of cruise fare** per person at the time of booking. Additional and final payment due dates are as stated on the first page of the booking form.

Cancellation and Refunds: Please make all cancellations in writing. The following per person cancellation charges will apply in addition to any charges assessed by our suppliers.
